

ACCESS PROCEDURE

- Enter via the boom gate after the roundabout with the smashed car sculpture on it (Entry 2).
- > Call Australian Chamber Orchestra via the boom gate intercom:
 - Press 4 then star (*) on the keypad at the boom gate OR
 - Phone the ACO Duty Technical Manager on **0447 095 200**, or the ACO Duty Front of House Manager on **0460 973 582**.
- > Turn on hazard lights.
- > Follow the ACO staff member to the destination.

SAFETY

- > PPE required: high-vis vest and closed toe shoes
- ➤ If there are any major obstructions that cannot be moved or additional assistance is required, please contact the ACO Duty Technical Manager on **0447 095 200**, or the ACO Duty Front of House Manager on **0460 973 582**.
- ➤ Pier 2/3 aprons, including the loading dock area, are often used by the public, including recreational fishers.
- ➤ If staff, hirers, or contractors find themselves faced with a threatening situation that may impact their personal safety during their work at Pier 2/3, they are to:
 - Remain calm and not provoke those that are behaving in a threatening way or aggravate the situation.
 - Call the Police (000) and or Ambulance if it's an emergency or if anyone is injured or at risk of danger.
 - Call ACO Management (ACO Duty Technical Manager on **0447 095 200**, or the ACO Duty Front of House Manager on **0460 973 582**.); and
 - Note details concerning the incident.

PARKING

- > There is metered on-street parking on Hickson Road and Pottinger Street.
- ➤ Nearby car parks:
 - Barangaroo Reserve Car Park (Entry: 5 Towns Place) 06:00 00:00 (Height 2.2m)
 - Barangaroo Point Car Park (Entry: 25B Hickson Rd) 05:00 00:00 (Height 2.1m)
 - Bond One Car Park (Entry: 26 Hickson Rd) 06:00 00:00 (Height 2.2m)

SPECIAL ACCESS

- > For any special vehicle movements that are outside of the above procedure, a Traffic Management Plan must be prepared and approved by ACO On The Pier and Create NSW.
- > Vehicle movements requiring a Traffic Management plan:
 - Vehicles movements outside of the standard vehicle access areas
 - Reversing vehicles
 - Vehicles over the max gross weight
 - Vehicles over max length
 - Use of forklifts
